WEDDING TERMS AND CONDITIONS

OUR PACKAGES

- All prices are valid for weddings up until 31st December 2029 and are inclusive of VAT at the current rate. For weddings after 31st December 2029, an increased price will apply due to increased supplier costs. If the VAT rate increases, prices will be increased accordingly.
- Occasionally, it may be necessary to vary the menu slightly due to limited availability of produce outside of our control.
- We reserve the right to alter menus, drink selections and prices at any time.
- We welcome your choice of bands and DJs, but need details of their Public Liability Insurance and any PAT testing requirements.
- We have an extensive list of local recommended suppliers with whom we have worked closely for many years. You are more than welcome to use any of your own, but please let us have their details when we meet you for the final time 6 weeks ahead of the wedding day itself.
- At this meeting we will discuss all final details. This is your opportunity to confirm the number of guests, food choices and accommodation you require.
- Wedding menu tastings are available for £40 per person. Please speak to your wedding coordinator to organise a date and sample menu.

OUR VENUE

- We only hold one wedding per day.
- We are licensed to sell alcohol until 11pm.
- We are licensed for live music until 11pm and recorded music until 11.45pm.
- It is not the policy of the hotel to provide the option of corkage.
- Our venue is accessible for any guests who struggle with mobility.
- Our licence prohibits the use of large outdoor structures, e.g. bouncy castles.
- Confetti is not permitted indoors and only biodegradable petals may be used in the grounds.
- We are unable to have fireworks (including sparklers) in the grounds.
- Our idyllic location in the Yorkshire Dales National Park ensures a picture-perfect setting for your photographs. We encourage site visits beforehand for any photographers new to our venue.

IMPORTANT INFORMATION REGARDING PAYMENTS

- Once you have chosen a date for your wedding, we will provisionally hold your booking for up to 14 days. If you are having a civil ceremony, this will allow you time to contact the local Registrars and check their availability for the date. At the end of the 14 days, we require a non-refundable deposit of £1,000.
- We will issue a wedding contract on confirmation of your wedding date.
- A pro-forma invoice will be raised for your wedding. 50% of the balance is due 6 months prior to your wedding date and the remaining balance is to be paid 1 month prior to your wedding date.
- Cancellation with more than 30 days' notice, prior to the wedding, will receive a refund of the balance paid. However, your £1,000 deposit is non-refundable.
- Both your deposit and full balance is non-refundable if your wedding is cancelled within 30 days of the wedding.
- We advise you to take out a wedding insurance policy.
